

The Susan Fund Reception

The 35th annual Susan Fund Awards Ceremony was held on Sunday, June 28th at The Center for Survivorship in Southport. The mood was joyful as the scholarship recipients, their families and friends, Board members and invited guests gathered to celebrate their academic and personal achievements.

Jeff Keith, Director of The Center, and one of the first recipients of The Susan Fund scholarship, welcomed the attendees and reflected on his personal

journey.



"Not a day goes by when I don't remember Susan. I was a student at Fairfield Prep and she was attending Staples High School. We were diagnosed at the same time. I survived and she did not. This influenced my decision to dedicate the rest of my life to raising money and providing on-going support services for people diagnosed with cancer."

The CT Challenge Bike Ride provides the funds and The Center for Survivorship provides the services and support. As in the past, each recipient was presented with a one year membership to The Center, which includes personal training sessions and access to classes. Jeff concluded his welcome by announcing a donation of \$25,000. Ann Lloyd, Susan's mother and president of The Susan Fund thanked Jeff not only for his continued support, but for hosting the awards ceremony for the past three years.

Ann noted, "This year we are celebrating the 35th anniversary of The Susan Fund." In 1982, scholarships were awarded to six recipients. In 2016, we awarded 29! Susan's brother, David, shared his thoughts about what made Susan such a special human being. "She loved life and embraced it. She radiated the spirit of Christmas throughout the year. As Susan battled cancer, she worried about how our family was doing. She went through a leg amputation, chemo and radiation and never stopped looking forward to attending college. This is the philosophy that The Susan Fund scholars have embraced."



This year's speaker was Logan Barer, a four-year scholarship recipient. Although he had prepared a speech, he told the audience that he was going to speak from his heart. Logan noted that, although receiving the financial support



is important, the emotional support is more significant. "Just knowing that there are people there who are holding you, who have been through the worst thing that people go through is so important. The Susan Fund is that constant, no matter what we are facing. That feeling is what makes me truly happy to be able to give back through participating in the Troupe du Jour fundraiser."

The ceremony concluded with Board member, Kathy DiGiovanna, awarding the scholarships. She stated that, this year, The Board awarded the most money ever. She introduced each recipient and captured the essence of each person's journey. As Kathy

stated, "Our scholars are outstanding, courageous and intelligent. They are mature beyond their years. Today is our scholar's day to celebrate life. We are fortunate to share in their glow."

Thirty-five years ago The Susan Fund, then known as The Susan Davis Lloyd Educational Memorial Fund, awarded its first scholarships to six recipients. Those scholars were:

Robert Adams: He grew up in Easton and attended Southern Connecticut State University. Unfortunately, he died while he was attending college.

Ken Barry: He grew up in Norwalk and graduated from Fordham University. He lives in Georgia and teaches speech therapy in the public schools. Cancer continues to impact his life, but Ken gains solace from working with young children. His hope is that he is making a difference in their lives.

Craig Hetzer: He grew up in Fairfield and graduated from Wesleyan University. He now resides in Los Angeles and works as the Senior Vice President and Creative Director for Knock, Knock, independent makers of clever gifts, books and stationery.

Amy Kamenick Dodson: She grew up in Wilton and graduated from Bucknell University. She lives in Burbank, Illinois and is a science instructor at Queen of Peace High School.

Jeff Keith: He grew up in Fairfield and graduated from Boston University. He has dedicated this chapter of his life to raising money and providing on-going support services to people who have been diagnosed with cancer. Jeff is one of the founders of The Center for Survivorship in Southport.

Antoinette "Toni" Suarez DeCarlo: She grew up in Stratford and graduated from the University of Bridgeport. Antoinette worked as an interior decorator. She and her husband, Russ, were parents of two sons and were the proprietors of The River Street restaurant in Milford. Antoinette passed away in 2006.

Eve Potts Reminisces

Although we were not close friends, I knew about Susan and her bravery in dealing with the amputation of her leg and her battle with cancer. After her death, Ann was determined to honor her with a memorial fund. She contacted the Candlelighters, part of the Leukemia Society, and started The Susan Davis Lloyd Educational Fund within that organization. In 1991, Ann set up a separate fund to specifically benefit the education of young people from Fairfield County who had dealt, as Susan had, with cancer at the crucial time in their lives - when they were planning on going to college.

I joined The Susan Fund Board and was part of the group that interviewed the first candidates. I was deeply affected by each of them. I was overwhelmed by their courage. I was buoyed by the hope we were able to give to them by bringing them together and acknowledging their unique needs. I left the Board about 20 years ago, but have kept up with the Fund's progress. It is exciting for me to see how The Susan Fund has grown both in the number of young people receiving grants and the amounts that are awarded. I attended this year's reception and was impressed with the courage, strength and

determination that each participant showed.

A mother's pain in losing a child never disappears, but Ann has made it her mission in life to keep Susan's memory alive with her unwavering dedication to The Susan Fund.

Wally Meyer Reminisces

Jeff Keith, the founder of CT Challenge, was one of the first recipient of The Susan Fund. At that time, based on his accomplishments, the Board felt there would never again be a candidate like Jeff. They soon found that all the candidates are like Jeff. They each have the same strong spirit (the strength to fight cancer) and generous spirit (the desire to help others). A college friend and Susan Fund supporter tells me that he looks forward to each new issue of the newsletter. He reads it cover to cover and particularly likes the bios. Reading them, he says, adds some "zing" to his life. What a tribute! I think reading those bios adds "zing" to all our lives!

Shelley Newman Reminisces

The Susan Fund is an amazing organization that I have been privileged to see grow from birth to maturity. I was a member of the Board of Directors for 35 years. I interviewed almost all scholarship applicants and always felt exhilarated after each session. They had such a positive attitude about their future and this spirit was contagious. What is now The Susan Fund started by being affiliated with Candlelighters, a self- help group of parents with children with cancer. I was Vice President of that group. After a few years it became an independent entity. The Fund has earned the reputation for impacting the lives of those who have been treated for cancer and their families. Especially inspiring to me is the large number of our scholars who volunteer to help others. Many have entered occupations related to cancer - oncology, nursing, pharmacy.

The Susan Fund annual award presentation is unique because it gives applicants the rare opportunity to share experiences and emotions with others who are or have been "in the same boat." I have given much time to The Susan Fund during the past 35 years, but it has given me much more than I have given to it. I have been blessed for it is always an inspiration to me.

35th Anniversary - Looking Back

Thirty-five years ago, The Susan Fund awarded its first grants. The recipients were special: young men and women battling cancer who — besides facing staggering medical bills — needed help paying for college.

This year, The Susan Fund — named in honor of Susan Lloyd, a popular, multi-talented Staples student who succumbed to bone cancer before she was able to attend Colgate University — reaches a milestone. It has distributed \$1.5 million, providing hope (and education) to hundreds of Fairfield County residents.

Every awardee's story is unique. But Kendall Mather illustrates just how powerful an impact The Susan Fund can have. Kendall grew up in Westport. She attended Greens Farms Elementary and Bedford Middle Schools. At Staples she was on the tennis team, and active in the St. Luke's Church youth group. Two years ago, near the end of junior year, the back, hip and leg pain she'd experienced for a while grew intolerable. The morning of her Advanced Placement Economics test, she could not walk. Several doctors thought it was a sports injury. But at Yale-New Haven Children's Hospital, Kendall was diagnosed with acute lymphoblastic leukemia. Kendall's cancer has a very high cure rate. Still, she underwent several rounds of chemo, and a few surgeries due to complications. She'll finish her treatment in October — soon after entering the University of Miami. (She took this year off, to focus on her health.) Friends and family have provided tremendous support. "When I was in my worst shape, they treated me normally," Kendall says.

The Susan Fund offers a different kind of support: financial. "Medical bills are a huge burden to many families," Kendall notes. "Even the scans to see if treatment is working are enormous. It's amazing what this Fund can do for families." Kendall is gratified to be one of the recipients. At Miami, she plans to major in business, with a focus on real estate. Then, when she embarks on her own career, with her degree (and a cancer-free diagnosis), Kendall looks forward to giving back to The Susan Fund. "They've helped so many people," she notes. "It's the least I can do."

Susan Baron – Board Member for 16 Years - Being on the Board for 16 years is an experience I treasure. The students we interview have become stronger and view life more positively as the result of their experience with cancer. They inspire me every day and teach me about the resilience of the human spirit.

Matthew Garnett – Board Member for 12 Years - As a survivor of childhood Non-Hodgkins Lymphoma, I was honored when, as a recipient, The Susan Fund supported me through my undergraduate and graduate education. The annual interview was special because the Board members got to know me. The financial support was great but knowing that they genuinely cared about me was even greater. It was wonderful to speak candidly about my experience with cancer and some of the issues that resulted from my treatment. Back then, there was a stigma to talking about such things. I was once again honored by The Susan Fund when they be asked me to join the Board. As a Board member who has been a recipient, it is a privilege to meet these students. We become a small part of their lives and have the gift of watching them mature.




