



LET ME TELL YOU A LITTLE BIT ABOUT MY SISTER, SUSAN...



It's been a long time, 40 years since Susan died. Sadly, a lot of my memories of her have been distilled. I don't remember how she looked when she laughed or the sound of her voice. What I do remember is the kind of person she was. Susan was so full of life. She had an infectious laugh. She was kind, thoughtful, hard-working and made others want to be around her. She had that kind of magnetism about her. I always knew that about her but I didn't know how tough she was until she was diagnosed with cancer, had her leg amputated, and was going through chemotherapy, radiation and more surgeries. Susan was the one who cheered us up. She would tell me, "The cancer is gone!" She fought tooth and nail. She thought of others throughout that time and maintained a certain grace. When I had my first college exams, Susan was having major chest surgery. She insisted that they did not tell me so I wouldn't be distracted. Who thinks that way at the age of 17? Susan was actually going to join me at Colgate the following year. She got in on the strength of her essay entitled "We Lloyds Are Tough." I don't know if it applies to the rest of us, but it certainly applied to Susan. She was so strong and selfless. She inspired me then and she still inspires me to this day.



Susan Davis Lloyd was a typical all-American teenager, entering her senior year at Staples High School, when she discovered she had osteogenic sarcoma. Despite having her leg amputated, Susan continued to participate in school activities and hold two jobs. A cheerleader and an outstanding student, she was accepted to Colgate University. Unfortunately, her chemotherapy treatments were not effective, and she was unable to begin college.

When Susan died, her many friends wanted to do something positive to remember her. The Susan Fund was established with the goal of helping other young people who have been treated for cancer attain their educational goals. The fund has continued to grow, and during the past 39 years has awarded more than \$1,824,600 in scholarships. Through the generosity of others, Susan's memory remains very much alive.



ALEXIA BOCCUZZI Stamford, CT University of Pennsylvania

Alexia describes herself as a "self-driven perfectionist." She was looking forward to finishing her senior year at Roxbury High School only to have it de-railed by COVID-19. Alexia is no stranger to adversity. Living with avascular necrosis, a degenerative bone condition. she has long been resolute. When she broke her hip in 7th grade during her treatment, she still made the most she could out of her summer. Whether it was floating in her aunt's backyard pool or getting wheeled around Aruba in a wheelchair, she made lemonade out of lemons. Alexia plans on continuing to do that at UPenn this fall, whether it's online or in person. She is planning to double major in Biology and Political Science and go on to attend medical school. Alexia would like to specialize in pediatric oncology. This is her first Susan Fund scholarship.



GIACOMO BRANCATO

Fairfield, CT Fairfield University Dolan School of Business

Not only did Giacomo celebrate five years in remission on June 25, he also celebrated a full recovery from COVID-19. Before he caught the virus himself, his semester of college was cut short. More importantly, his baseball season was cut short too. A day after an exciting win against Stetson in Florida, he found out that his season was over and he would be flying back home immediately. Months later, his plans of playing summer ball disintegrated, too. Depending on the pandemic, Giacomo plans on living off-campus this fall while earning his finance degree. Because he lost this baseball season, Giacomo is considering red-shirting to not only have another year of eligibility on the field, but also an opportunity to earn a business degree as well. This is Giacomo's fourth year as a Susan Fund recipient.



LAUREN BUSSER

Newtown, CT New York University Brooklyn

Lauren will be pursuing a Master's degree in Integrated Digital Media at NYU-Tandon. Her ideal job would be to work as a digital product designer, which would include user interface and user experience. For the past four years, Lauren has been working with Tell-Tale TV reviewing television shows and interviewing celebrities. Some of the TV series she has enjoyed reviewing are *Orange Is the New Black, Little Fires Everywhere* and *Blindspot.* She also aspires to write a science fiction novel. For now, Lauren is prioritizing design and nonfiction work. She is a returning Susan Fund scholarship recipient. She earned her undergraduate degree from Sarah Lawrence University and was awarded her scholarships from 2008 through 2011.



JOSE CAMPANARIO

Danbury, CT Western CT State University

This is Jose's first Susan Fund scholarship. After earning outstanding grades at Danbury High School, Jose looks forward to furthering his education and ultimately becoming a successful financial advisor/trader. Despite receiving his cancer diagnosis during his junior year, Jose was determined to graduate on time and took many summer classes to accomplish this. Jose's letter of recommendation cited his "tenacity and strength of character." It went on to say, "He spent the better part of the last year enduring the often times unendurable and has exuded grace along the way."



CHARLIE CAPALBO *Fairfield, CT* Fairfield University

Charlie spent most of the 2019 in-patient at Boston Children's Hospital in isolation or recovering. In January 2020, he was back at Fairfield U and living on campus with his roommate, George, the family's French Bulldog. He is majoring in Business with a minor in Psychology. Charlie, a dedicated hockey goalie in high school, remains an avid hockey fan. His first day out of isolation after his Bone Marrow transplant, he headed to Wonderland of Ice to skate before the rink was open. Owner John Ferguson was there to welcome him back on the ice and said, "I had chills and cried watching him skate. Charlie has such a wonderful personality and a heart of gold." This is Charlie's third Susan Fund scholarship.



JOSH CAPPELLO

Trumbull, CT Ithaca College

This is Josh's second Susan Fund scholarship. He is working towards a double degree in Journalism and History. Josh's educational and career goals remain steadfast as he faces treatment for a recurring cancer. Josh plans to attend a local university during his year of treatment and will then look into other options to further his education. His long-term goal is to become a political journalist. His letter of reference stated, "Josh is tenacious and hardworking so his path makes perfect sense to me!"



RYAN CAULFIELD

Westport, CT University of Pittsburgh

Ryan is a senior at the University of Pittsburgh majoring in Nursing and Economics. He has been a member of The Nursing Student Association and the Men In Nursing organization. This past summer, Ryan completed a nursing internship in Pittsburgh at the UPNC Hospital at Shadyside. He worked on the surgery step-down floor and in the Emergency Room. During his senior year, Ryan hopes to intern on a trauma floor. He plans to attend graduate school for Nursing Anesthesia and eventually become a Hospital Administrator. This is Ryan's fourth Susan Fund scholarship award.



JACK DEMERS

Bethel, CT Eastern CT State University

Jack completed his first year at college with an outstanding GPA. After considering majoring in Sports Management or Education, Jack is now looking to pursue a career in the Communications field. Because the summer camp Jack was hoping to work at was cancelled due to the pandemic, he worked at his father's business, New England Compost, a Danbury-based company that recycles food waste into organic compost. His letter of recommendation said, "The words that describe Jack would be reliable, hardworking, and willing to do anything asked of him." This is Jack's second Susan Fund award.



DEANNA EAST Stratford, CT UCONN - Storrs

This is Deanna's fourth Susan Fund scholarship award. Deanna is in her senior year at UCONN where she is majoring in Molecular and Cell Biology. She will be a Research Assistant at the Children's Medical Center where she will conduct her own research. Deanna would also like to work with babies. Deanna plans to be a pediatrician and perhaps focus on oncology/hematology or the ER. She was recently elected as a senator in UCONN's student government and will be visiting the Capitol as an advocate for increased student funding. Deanna's ministry leader describes her best, "People like Deanna are necessary because it is people like her who infect and affect the good in the lives of others."

Despite COVID-19 and her medical challenges, Jasmyn has continued clinical assignments as she works to finish her RN program at Naugatuck next summer. While taking online classes, she works every day at Cambridge Manor and enjoys interacting with patients of all ages and backgrounds. Her supervisor wrote, "Jasmyn's work ethic and professionalism are greatly admired... She is reliable, trustworthy and possesses a can-do attitude." This is her fifth year as a Susan Fund recipient.



JACK HAVARD

New Canaan, CT Gettysburg College

Jack has one semester remaining before he graduates with a major in Organizational Management and double minor in Business and Economics. His goal is to pursue a career as a management/business consultant. Jack served as the Inter-fraternity Council Scholarship Chair at Gettysburg. He also sends care packages of toys and prizes to the Hassenfeld Children's Hospital Clinic at NYU Langone, where he received his treatment. Michael's letter of recommendation said, "Michael is able to use his past as motivation to achieve his goals for the future, which is a thrill to see as an academic advisor." This is Michael's second Susan Fund scholarship.

Her noble ambition to pay these lessons forward and study pediatric oncological nursing makes her an ideal recipient of a Susan Fund Scholarship."



JOSHUA RUBENSTEIN

Trumbull, CT University of Maryland College Park

Josh is a graduate of Trumbull High School and is in his freshman year at Maryland. He wrote, "Seeing firsthand the commitment, bravery and heroism of the doctors who saved my life, I feel that it is my destiny to eventually become a Pediatric Oncologist." Volunteerism has played an important role in Josh's life. At Trumbull High School, he was the President of the Infinite Love Junior Board. It works with the Infinite Love Foundation, an organization which was established in Connecticut to "raise awareness and fund research in regards to all things childhood cancer, but most importantly to support children and their families in their fight." He has also been an ambassador for The Casey Powell World Lacrosse Foundation and met with a child who was being treated for the same cancer he had. This is Josh's first Susan Fund scholarship.



CORDELIA SCUDDER West Haven, CT Sacred Heart University

This is Cordelia's sixth Susan Fund scholarship. She is working to obtain her Masters in Social Work. In addition to pursing her degree, Cordelia was a substitute teacher in the Bridgeport area prior to schools closing due to the pandemic. She wrote, "I have a lot of work to do with these children. They have so many complex issues and they are willing to discuss those problems with me." Her letter of recommendation describes Cordelia as, "a pillar in her community and church. Her faith is evident as she freely gives to those less fortunate and a hand to those in need. Her positive energy and contagious smile make her a delight to be around."



PATRICE TSOPANIDES

Fairfield, CT Southern CT State University

Patrice is a senior at Southern Connecticut State University majoring in Sociology and Criminology. She plans to intern either in law enforcement, public relations or at DCF. Patrice knows she would like to work in helping people to improve their lives. She has worked at the Mission Training Center for two years and is a member of their Adventure Athlete program which enables her to work out with a trainer. This keeps her healthy and strong. Her manager at Mission wrote, "Patrice is such a wonderful example of not only a young cancer survivor but of someone with resilience and determination to succeed no matter what obstacles may stand in her way." This is Patrice's second Susan Fund scholarship award.



JACK UNGAR

Darien, CT University of Richmond

Jack graduated from Middlesex Prep School and will begin his college career in the fall. He plans to major in Psychology. Jack has been involved with his volunteer fire department and obtained his EMT license. Jack eloquently spoke to the Susan Fund Board about his desire to directly help people in need and about discovering his passion to become a firefighter at an early age. His letter of recommendation explained that Jack had been the recipient of Middlesex's Hervey Thompson '24 Award which, by vote of the faculty, is presented to that student who, by fortitude of character and exercise of will, has demonstrated exceptional courage and resiliency in becoming an accomplished student in athletics or academics or artistry. This represents how deeply Jack has inspired his school community with the way in which he has faced hardships and obstacles.



Thankfully, his brother Will was a 90% match as a marrow donor. As an avid hockey player his whole life, Charlie describes it as "in goalie perspective, Will made a once in a lifetime save."

While Charlie underwent his aggressive treatment to battle the disease, he stayed positive by envisioning even the smallest details of being back on the ice, either coaching, playing or just watching the game. After three years of fighting back-to-back cancers, Charlie made his dream of getting back on the ice a reality, where he finally "felt home again."

Having been to other scholarship interviews, I thought this must be some sort of ruse to lull me into a false sense of security. Once my interviewing defenses were lowered, they would certainly attempt to catch me off guard and send me home as just another applicant. Soon I found out, the exact opposite was true.

That collection of strangers in the "Board Room" continued the relaxed and casual nature of the conversation which made my time with them more akin to sitting at a Thanksgiving table of extended family members than an intense interrogation of my merits. Having expected to be peppered with multifaceted questions, I very much welcomed their smiling faces; they wanted to know and befriend me. The fifteen minutes we spent together flew by and I, again, returned to those windy backroads, except now with a loosened tie, skip in my step, smile on my face, and the sense of knowing I had just been in very good company! Having joined the Board in 2015, that positive energy remains a staple of the Board's interview process each spring. At the very core of our Board, behind the welcoming faces and entertaining dialogue, is a wellintended aspiration to know and create genuine relationships with the courageous individuals who have or are experiencing the shared obstacle of a cancer diagnosis. Our scholars' ambition to overcome and better themselves by continuing their educational pursuits demonstrates there is still positivity and good-hearted people in this world who wish to make a difference. I am very grateful to be a member of The Susan Fund Board.

LOGAN BARER



I was diagnosed with Stage III melanoma at age nine and went through my course of treatment. Fast forward a few years and I was lucky enough to become a four-time Susan Fund scholarship recipient which helped me to attend Ithaca College. I started as an Environmental Science major, but switched to Communication Studies in my sophomore year. After graduating, it took me

some time to find my niche while doing some baseball writing, coaching, and substitute teaching. I have recently found a career at Momentum Solar, helping people save money and, more importantly, helping the environment, which has always been a passion of mine.

I am elated to be the newest member of The Susan Fund Board and hope to be a part of it for a very long time. I remember my very first interview - going to the Westport library and asking the librarian to help me find the conference room where the Susan Fund Board was waiting for me. 




Matthew T. Senatore, Fairfield University of Connecticut


