The Susan Fund Reception

The 34th Annual Susan Fund Awards Ceremony was held on June 28th at The Center for Survivorship in Southport. Twenty five Fairfield County cancer survivors were awarded scholarships. Jeff Keith, the director of The Center and one of the first Susan Fund Scholarship recipients, welcomed the students and their families, The Susan Fund Board members and invited guests.

Jeff reflected on his cancer experience and how The Susan Fund scholarship impacted his life. Several years ago, he changed careers and founded The Center for Survivorship, a facility whose mission is "to empower cancer survivors to live healthier, happier and longer lives." The Center is the first standalone survivorship facility in the country; it emphasizes exercise and nutrition as the key ingredients to a healthy lifestyle.

Jeff introduced Ann Lloyd, the president of The Susan Fund, and presented a \$25,000 contribution from The Center to The Susan Fund, which Ann founded in memory of her daughter, Susan Davis Lloyd. Susan's dream was to attend Colgate University. Although that aspiration never became a reality, throughout the 34 years of The Fund's existence, Susan's dream has remained alive for other cancer survivors

Will Lloyd, Susan's brother, also spoke of Susan and recalled her humor and the secret language that he could never understand. His description of his sister and her courage during her illness conveyed an understanding as to why this Fund is important to all of the recipients.

A Unique Program For Susan Fund Recipients

The Center for Survivorship created a special program for Susan Fund scholarship recipients. It was presented to them at the reception and is designed to promote good health through proper nutrition and exercise. When they are home they can:

- Participate in 10 complementary personal training sessions with an ACSM/ACS Certified Cancer Exercise
 Trainer
- Meet with the nutritionist for five sessions
- Have unlimited access to the Center's classes which include yoga, Pilates, indoor cycling, TRX, meditation and strength training as well as to the cardio equipment
- Visit the library, the meditation and healing garden.
- Sign up for one-on-one personal training and nutrition counseling packages at discounted rates

When they are at school, the students are given customized 30 minute express workouts and can check in with their trainer. Our thanks to the Center for Survivorship for providing this unique opportunity for The Susan Fund scholars.



Spotlighting a Current Recipient

Brittany De Nigris

Two-time scholarship recipient Brittany De Nigris has dazzled The Susan Fund Board with her many artistic talents. This year, Brittany riveted us with her story of working with men who are on death row at Riverbend Maximum Security Institution in Nashville, TN. Eleven of these inmates have designed and created their own death-monuments and anti-monuments which appeared in an exhibition called "Life After Death and Elsewhere," that opened on September 9th at APEX Arts in Manhattan. Shown in tandem with these works was a video piece created by Brittany and fellow MFA candidate Moses Williams, which explored the act of storytelling, creating meaning through place and metaphor. Underlying themes examine our current system of punishment.

As Brittany explained, "Visiting death row inmates in a maximum security prison is not an easy experience to describe. The entire thing still feels oddly surreal. I went in knowing very little about what to expect, I knew nothing about what prison life is like, how these men came to be there, or how they would react to my presence. I went in only knowing that I wanted to help facilitate getting their work out into the world, with no way to predict how this visit would make me feel, or equip me to do this work.

I feel almost selfish in drawing comparisons between myself and them. Many of these men have spent years in solitary confinement, have not seen the sky at night or walked on grass in decades and await their sentence. When I was diagnosed with cancer, I felt separate from the world, immobilized, seized by something larger and out of my own control. I spent a lot of time alone, in my bed, at my parent's home where I grew up and felt the sharpest, deepest, loneliness.

I remember at one point thinking that there are many people out there suffering far worse every day, and that is

why I chose to be involved in this project. Although our circumstances are different, everyone feels pain, and this felt like an opportunity to soothe pain, however small.

When I was sick, I thought that I could work my way through it by making art, but I often felt too tired to do much of anything and simply stared at the wall or watched bad television. Now, I think of these men, locked away in prison cells, learning to let themselves be artists as a means of survival. I admire their determination to find a way through what, for many of them, has been a lifetime of sad circumstances. One man saves everyone's uneaten bread, mixes it with water to form a clay that he uses to sculpt flowers. Another paints himself going on walks with someone

he loves in a garden outside of the prison walls. I have many complicated emotions around this project, ranging from fright to satisfaction to impotence. But ultimately, it is teaching me a great deal about our deepest, strongest,

Spotlighting Past Recipient

Christine Ercole



In November, 2000, I was diagnosed with Acute Lymphoblastic Leukemia. I had just turned 11 years old and begun my first year of middle school. I was treated for 2½ years at Connecticut Children's Medical Center. During that time, my days were filled with aggressive forms of chemotherapy, spinal taps, bone marrow aspirations, hospital stays, and six hour blood transfusions; you know typical 11 year old kid activities. My cancer diagnosis was the event that precipitated change and insight in my life. Initially, I viewed cancer as an annoyance simply because it interrupted my life. It interfered with me seeing my friends at school, spending the holidays with my family, and just being a normal 11 year old kid. When I completed my treatment, I wanted to distance myself from the whole experience. It's not that I didn't want to talk about it; I just never wanted to be the girl defined by cancer or ever play the 'cancer card.' But as I grew older, I realized that this was too momentous of an event to ignore.

During my treatment, the nurses were the ones I established the deepest bonds with and the ones I spent the most time with. When there were times I had to go to

the hospital three days a week for six hour transfusions, it goes without saying that I got to know the nurses pretty well. They created an extra support system in addition to my family and friends and mitigated the entire experience. This impacted who I am today and influenced my decision to attend the Yale School of Nursing, where I trained to become a psychiatric nurse practitioner. I am forever grateful to The Susan Fund for providing me with the support and assistance to finish my undergraduate and graduate degrees.

My first nursing job was through the Fresh Air Fund, where I worked as one of the camp nurses at their all-boys 9-12 year old camp. The summer consisted of four sessions, serving over 200 boys, which meant we had over 800, nine to twelve year old boys passing through our camp. This was a bit overwhelming at times and quite the way to break into the field of nursing, but it also ignited another passion in me and helped guide my career path. I worked another summer at camp after I completed graduate school and then began my search for a nurse practitioner job working with a similar population. In January, 2015 I began my first job at a foster care agency in the Bronx called Jewish Child Care Association. I am the full-time prescriber there and also conduct multiple psychiatric evaluations weekly. It has been quite the journey, but I am glad my experiences have guided me to this point in my life, serving this population. I am very lucky that I have been able to continue to work for the Fresh Air Fund; I worked weekends at multiple camps this summer as well as off-season weekends in both the fall and spring. When I'm not working, I'm trying to take advantage of living in New York City. I want to thank The Susan Fund for supporting me on this crazy journey and helping others make their way as well.



Spotlighting Past Recipients

Samantha Dommermuth

Greetings from Philadelphia! I am a seven-time Susan Fund scholarship recipient as well as a cancer survivor, speech language pathologist, chronic laugher and life enthusiast!

My "cancer history" dates back to 1998 when I was diagnosed with Chronic Mylogenous Leukemia (CML) at the age of 10. The only cure for CML is a bone marrow transplant, preferably from someone the patient is related to. My very Italian-looking brother and sisters all matched each other perfectly. However, I shared a rare Italian antigen with my father, which made the prospect of receiving bone marrow from a family member extremely unlikely. We turned to the national bone marrow registry and it was there, months later, that we found an 18-year-old biochemistry major at Boston University who was a perfect match.

After a successful transplant, I developed Graft versus Host Disease (GVHD), which happens when your body fights your new bone marrow's antibodies. Their favorite war zones are your organs, and that's where they raged for the next three years. After years of various treatments, including receiving TCELLS from a horse and being homeschooled due to a suppressed immune system, my bone marrow and body made peace with each other, and I was able to start a "normal" life again just in time to begin high school.

My relationship with The Susan Fund started 10 years ago. I was a wide-eyed 18-year-old ready for my first year at the University of Connecticut. During the next four years, The Susan Fund and all the amazing individuals on the Board stood by me as I worked my way through various programs and, ultimately, found my niche as a communication science disorders major. I was accepted to Temple University's Speech Language and Hearing Sciences master's program and moved to Philadelphia after my graduation from UConn. Again, The Susan Fund was by my side as I worked through my graduate program and ultimately became a Speech and Language Pathologist (SLP).

Currently, I live in Philadelphia's Chinatown and work at Alfred I. DuPont Hospital for Children in Delaware as an SLP in outpatient rehabilitation. I love my job. Every child I treat is more amazing than the next. I have come across children who have gone through various cancer treatments, and I'm even playing in an upcoming Philadelphia cornhole tournament with a fellow GVHD patient! Our team will be called "Second Chance" and I can't think of a more appropriate name. I am so lucky for my second chance and so grateful for the people, like The Susan Fund board members, who have helped me live. I continue living my second chance to the fullest.

In 2010, when I first came to The Susan Fund, I was extremely nervous. During my interview, I was met by the



kindest Board members who put me at ease. I was asked if I wanted to participate in The CT Challenge bike ride. I hadn't been on a bike for about five years but I agreed anyway. I am so happy that I did. That year I rode 25 miles. I had nine year olds passing me on the route and was probably one of the slowest riders. With the help of a fellow participant we completed The Challenge and had fun along the way.

This year, I received an e-mail from Ann Lloyd asking if I wanted to participate in an adventure trip sponsored by First Descents and The CT Challenge. I am so glad that I accepted! The options were surfing, whitewater kayaking, ice

climbing or rock climbing. I dove head first into whitewater kayaking in Missoula, Montana. I expected it to be easy for cancer survivors, but it was an incredible challenge and an amazing accomplishment. I left every day with my arms and shoulders a little more sore, but also a little stronger. The staff was amazing. They were energetic, fun and understanding. They were constantly helping us along the way. I made life-long connections with participants and staff.



I am extremely proud of myself for accepting the challenge and rising up to it time and time again. Thank you Susan Fund and The CT Challenge for helping me achieve my dreams and then some. What a once in a lifetime experience!


Jasmine is also a member of the Purple Light charity, which raises money for breast cancer awareness.


